MOVED by Isabell, seconded Caloia to amend the previous motion that SH07-22 is suspended for the remainder of the 2007-2008 school year. Must go through the reinstatement committee, including full documentation from the therapist regarding sexual conduct. During the expulsion period, SH07-22 is not allowed on school property nor allowed to attend any Redford Union School function.
