

SPECIAL MEETING MINUTES – BOARD OF EDUCATION

 January 7, 2008

A special meeting of the Redford Union Board of Education was held January 7, 2008, at the John C. Raeside Administration Building, 18499 Beech Daly Road, Redford Township, Michigan. President Pytel called the meeting to order at 6:30 p.m.

MOVED by Caloia, seconded by Wujcik that student SH07-14 is suspended for 180 school days and upon return the student will attend Pearson Alternative Education Center. Wujcik-Yes, Calvert-No, Pytel-Yes, Isabell-No, Gubachy-No, Caloia-Yes, Brenner-Yes. Motion: Carried.

Parent of student SH07-15 was present for the hearing. Neil Thomas, Director of Special Services read the charges and recommendation of the Review Committee. At the end of the discussion it was MOVED by Caloia, seconded by Wujcik that student SH07-15 is suspended for the remainder of the 2007-2008 year and return to Pearson Alternative Education Center in September 2008.
