President Gubachy called the meeting to order at 6:00 PM.

The candidate was escorted into the room and introduced by Greg Sieszputowski, Director of Leadership Development & Executive Search of Michigan Association of School Boards. Mr. Sieszputowski was the moderator for the first round of interviews.

President Gubachy welcomed the community members and thanked them for taking the time out to join the meeting. She stated that members of the audience who wished to provide feedback could complete an interview feedback form following each interview. The completed feedback forms would be copied and distributed to all board members.

3<sup>rd</sup> Candidate Interviewed:

President Gubachy welcomed Dr. Shaun Black and she explained the interview process.

Questions were asked by the Board members.

The Board thanked Dr. Black and Dr. Black thanked the Board.

President Gubachy reminded the in-person audience and virtual audience about the feedback form.

President Gubachy called recess at 7:12 PM.

The Board went back to session at 7:21 PM.

President Gubachy welcomed the community members back and she gave a reminder of the feedback forms. The feedback forms would also be available at the end of the next interview. The Board members would get a copy of the feedback forms.

2<sup>nd</sup> Candidate Interviewed:

President Gubachy welcomed Dr. Jeffery Robinson and she explained the interview process.

The Board asked Dr. Robinson a series of questions.

The Board thanked Dr. Robinson and Dr. Robinson thanked the Board.

President Gubachy reminded the in-person audience and virtual audience about the feeback form. The Feebback form would close in 10 minutes.

The Board went back to order at 8:35 PM.

Moderator Greg Sieszputowski explained the process to the Board. The Board would get copies of the Feedback forms to review along with their personal notes. The Board would discuss each candidate and a poll would be taken.

Each Board Member shared their thoughts about all four candidate. Discussion ensued.

Board of Education Communication/ Discussion

The Board was asked to select up to two candidates each to return for the second-round of interviews. The results of the poll was five for Dr. Robinson and four for Jasen Witt and two for Dr. Black. Both Dr. Robinson and Jasen Witt were selected to return for the second-round of interviews.

Moderator Greg Sieszpotowski confirmed the Board's initial timeline where they scheduled the second-round of interviews for April 27, 2021 at 6:00 PM.

Moderator Greg Sieszputowski said that he would coordinate Dr. Robinson's district tour and the candidates Virtual Open Houses with Jackie Warren, Administrative Assistant to the Superintendent. The tour and the Virtual Open Houses would also be on April 27, 2021.

Mr. Sieszputowski asked the Board to send interview questions to him. Mr. Sieszputowski would also send the Board a question bank that they could select questions from. For the second round of interviews, the candidates did not have to have the same questions. Each candidate would have a total of 75 minutes for their interview which would included a 12-15 minute presentation.

Mr. Sieszputowski would get background checks going for the Board and the Board would receive reference check assignments from him. The Board was instructed to only call and check the candidates references that they have been assigned. If the reference sugguest they talk with someone else as well, that would be fine for them to call that person. The reference checks would be shared with the entire Board to help them with the second-round of interviews.

The Board had discussion.

Both Vice-President Pridemore and Trustee Caloia expressed their concern about the Virtual Open Houses and the possibility of Mr. Witt and Dr. Robinson being abused due to the temperature of the district.

Trustee Bailey, Secretary Robinson, and Trustee Gray gave their support for the Virtual Open Houses.

Mr. Sieszputowski said he would be in the Zoom rooms to monitor the Virtual Open Houses and he would get a colleague to assistant.
