Superintendent Witt said that they will have to track the student outcomes within these co-taught classes over time. However, the one thing that this model does immediately is any student who, instead of being assigned to a resource room class, is assigned to a Co-taught class. For those students, we have reduced their amount of time in the least restrictive environment.

Mr. Smigliani from Plante Moran Cresa said that he hopes the Board was able to see some of the information with regards to bidding as it was prepared. They also transferred actually showing plan strategies for the work going forward as they know this is not a linear process of everything that is good to go forward to show a little bit of how the plan permitting construction kind of needs feathered together. They put together a narrative and tried to outline that process a little bit to make it clearer for the Board. He said they really did not have much of a presentation, they really wanted to open it up to the Board to ask questions. Superintendent's Remark:

Superintendent's Remark

Superintendent Witt mentioned the Annual Redford Union Athletics Golf Classic is coming up on Sunday, June 25th at Fox Creek, and Whispering Willows. The start time is 8:30 AM. He gave kudos to Mr. Taylor. Redford Union High School Principal and Mr. Tomasaitis, Director of Facilities and Grounds. They both are huge organizers and highly involved with the organization and operation of this event.

The Board were sent information and also more information will be sent to them by e-mail this week about the Superintendent evaluation process.

Superintendent Witt said that they have identified a trainer named Rod Green, Consultant from MASB, that is going to be able to come to the District in June and meet as needed with the board. He will discuss that process tomorrow with Mr. Green, and he will then coordinate with Mrs. Pridemore and the rest of the board after that to make sure that that process still occurs here before June 30th. He has also been working with some others on the team to collect information relative to the Superintendent Goals that were established during the course of this school year and agreed upon by himself and the Board of Education.

The Board is required by law to be trained before they can evaluate the Superintendent and they are required to evaluate him every year.

There will be a need to schedule another Board Meeting in June, sometime after the June 19<sup>th</sup> meeting for the purpose of evaluating the Superintendent.

Superintendent Witt will try to get the training set up for June 19th and that would give everyone an opportunity to be trained and familiarized with the instrument and then the evaluation process would take place from there.

In terms of next year, they will start the Superintendent Evaluation conversation in February 2024, and in the future, it would be great if they would agree to have the pieces of this scheduled by the end of April 2024.

It was said that they may also need to set quarterly touch bases to see where they are progressing.
